MINUTES OF BUDGET CLOSE OUT MEETING, JUNE 25, 2019

The Scott County School Board met for a Budget Close out Meeting on Tuesday, June 25, 2019 at the Scott County School Board Central Office, 340 E. Jackson Street, Gate City, Virginia with the following members present:

APPROVAL OF CAFETERIA FUND AND SCHOOL OPERATING FUND CLAIMS AND CLOSE OUT OF THE 2018-2019 SCHOOL BUDGET: On the recommendation of Superintendent Ferguson and on a motion by Mr. David Templeton, seconded by Mr. Steve Sallee, all members voting aye, the Board approved the Cafeteria Close out with a cash balance of \$229,628.52, expenditures of \$77,285.23, and a remaining balance of \$152,343.29.

On a motion by Mr. David Templeton, seconded by Mr. Steve Sallee, all members voting aye, the Board voted to approve the School Operating Fund expenditures in the amount of \$877,800.84 with a cash balance of \$937,107.05. Should any adjustments be necessary, Superintendent Ferguson has the authority to make the necessary adjustments to the expenditure list to close out the 2018-19 School Operating Fund to result in a zero balance.
