<u>CALL TO ORDER/MOMENT OF SILENCE/PLEDGE OF ALLEGIANCE:</u> Chairman Quillen called the regular meeting of the Scott County School Board to order at 6:30 p.m. and welcomed everyone to the meeting. The members and audience observed a moment of silence and Mr. David Templeton led in citing the *Pledge of Allegiance*.

<u>APPROVAL OF AGENDA</u>: On a motion by Mr. Gail McConnell, seconded by Mr. Larry Horton, all members voting aye, the Board voted to approve the agenda as presented.

<u>APPROVAL OF MINUTES – FEBRUARY 5, 2019 REGULAR MEETING:</u> On a motion by Mr. Steve Sallee, seconded by Ms. Linda Gillenwater, all members voting aye, the Board voted to approve the February 5, 2019 meeting minutes as presented at the meeting as amended.

<u>APPROVAL OF CLAIMS:</u> On a motion by Mr. David Templeton, seconded by Mr. Steve Sallee, all members voting aye, the Board voted to approve the claims on March 5, 2019 as follows:

SALARY/FRINGE BENEFITS PROPOSAL FOR THE 2019-2020 SCHOOL YR.: (APPENDIX A)

Assistant Superintendent Jason Smith spoke to the Board on behalf of the Salary/Fringe Benefits

Committee with the proposal for the 2019-2020 school year and the recommendations from the committee's meeting. The committee is recommending to the Board that school begin for the 2019-20 academic year on August 12, 2019.

On a motion by Mr. David Templeton, seconded by Ms. Linda Gillenwater, all members voting aye, the Board voted to approve the calendar as presented by the Salary/Fringe Benefits Committee for the 2019-2020 school year.

Mr. Smith explained the proposals set forth by the committee recommends funding a step increase for all eligible employees and 3.5 % salary increase, based on actual salary, for all employees, and that the salary increase be reflected in the upcoming 2019-2020 salary scale. 2. The Committee recommends continuing (a) to maintain health insurance premiums for employees at the lowest possible rates without a reduction in benefits, (b) to offer the sick leave bank to eligible employees, (c) to provide assignment-free lunch for elementary teachers, and (d) to issue employee contracts as early as possible before the end of the 2018-2019 school year. 3. The committee recommends increasing the salary Step 29 to \$60,000.00. 4. The Committee recommends developing a policy to donate sick leave days to employees who need it. 5. The committee recommends funds to be budgeted to support appropriate staff development for licensure renewal. 6. The committee recommends increasing the Master's degree pay to \$2,277 and Doctorate pay to \$3,000.

PUBLIC COMMENT: There was no public comment at the March 5, 2019 meeting.

<u>SUPERINTENDENT'S REPORT: APPROVAL OF REQUEST FOR LINE OF CREDIT FOR 2019-2020</u>
<u>SCHOOL YEAR:</u> Superintendent Ferguson explained to the Board that he was requesting the 4 million dollar line of credit for the 2019-2020 school year approval from the School Board and with their approval would be requesting the approval from the Scott County Board of Supervisors at their March 6,

2019 regular meeting the following morning.

On a motion by Mr. Gail McConnell, seconded by Mr. Larry Horton, all members voting aye, the Board voted to approve Superintendent Ferguson to secure the four million dollar line of credit for the 2019-2020 school year.

APPROVAL OF COURSES FOR THE 2019-2020 SCHOOL YEAR: (APPENDIX B) Superintendent Ferguson presented 3 courses for approval by the Board on behalf of Jennifer Frazier, secondary Supervisor. The first course code he presented was 6617 for Grade levels 9-10 with High school credit: 1 Digital Applications. This course is designed for secondary school students to develop real-life, outcome-driven approach skills for digital citizenship, basic computer operations, keyboarding, and application software (word processing, spreadsheets, multimedia applications, databases), and career exploration. The second course he explained to the Board for approval was Earth Science II-Advanced Survey of Earth Science Topics for Grades 11-12. The prerequisite for this class he explained is Earth Science 1 and gives the students one high school credit. In this coursework, the student will continue their study of earth science in this upper level science course. Earth Science II will build on the concepts learned in Earth Science I. The Earth Science standards connect the study of Earth's composition, structure, processes, and history; its atmosphere, fresh water, and oceans, and its environment in space. The standards emphasize historical contributions in the development of scientific thought about Earth and space. The standards stress the interpretation of maps, charts, tables, and profiles; the use of technology to collect, analyze, and report data; and the utilization of science skills in the systematic investigation. Problem solving and decision making are an integral part of the standards, especially as they relate to the costs and benefits of utilizing Earth's resources. Major topics of study include plate tectonics, the rock cycle, Earth history, the oceans, the atmosphere, weather, and climate, and the solar system and universe. This course will provide a meaningful watershed educational experience that will enable students to graduate with the knowledge and skills to act responsibly to protect and restore their local watershed. Thirdly, Calculus II was presented for approval for Grade 12 with a Prerequisite of Calculus 1 giving the student 1 high school credit. Calculus II is designed for students pursuing an advanced high school diploma and recommended for students interested in careers in mathematics,

science, or engineering; also Calculus II Dual Enrollment which gives the student 4 college credit hours was presented with 2 high school credits; Calculus II Dual Enrollment is also designed for students pursing an advanced high school diploma and recommended for those interested in careers in mathematics, science, or engineering.

On a motion by Mr. David Templeton, seconded by Ms. Linda Gillenwater, all members voting aye, the Board voted to approve the Course Code: 6617 Digital Applications for Grade Levels 9-10 with a high school credit of: 1 for the 2019-2020 school year.

On a motion by Mr. Gail McConnell, seconded by Mr. Larry Horton, all members voting aye, the Board voted to approve the Course for the 2019-2020 school year – Earth Science II for Grades 11-12 requiring a Pre-requisite: Earth Science I with a high school credit: 1 for students.

On a motion by Mr. Larry Horton, seconded by Mr. Steve Sallee, all members voting aye, the Board voted to approve the Calculus II and Calculus II Dual Enrollment courses for Grade 12 requiring a Pre-requisite of Calculus 1 and Calculus 1 (Dual Enrollment), Calculus II and Calculus II Dual Enrollment both give the student 1 high school credit; Calculus II Dual enrollment gives the student 4 hours of college credit.

<u>UPDATE ON THE 2019-2020 SCHOOL BUDGET:</u> Superintendent Ferguson gave the Board an update on the 2019-2020 school budget-He stated that the Senate and General Assembly's version of the budget was updated in a February 24th publication. Over the biennium, monies would be available for a 5% increase in salaries based on standard of quality positions.

APPROVAL OF APRIL MEETING DATE CHANGE: Due to a scheduling conflict, Superintendent Ferguson asked the Board's approval for the prior approved April meeting date of Tuesday, April 9, 2019 to be changed to Thursday, April 11, 2019.

On a motion by Mr. David Templeton, seconded by Mr. Larry Horton, all members voting aye, the Board voted to approve the April meeting date change from Tuesday, April 9, 2019 to Thursday, April 11, 2019.

APPROVAL OF \$400,000 CONSTRUCTION LOAN EXTENSION: On a motion by Mr. Gail McConnell, seconded by Ms. Linda Gillenwater, all members voting aye, the Board voted to approve the request to submit to the County Board of Supervisors to authorize the Treasurer to apply for a line of credit to be used for construction purposes in the amount up to \$400,000 a year for the school system. This line of credit would be open ended, not having an ending date. At a minimum, the interest earned off of the money borrowed would be paid at the end of each fiscal year if not more than the minimum amount.

APPROVAL OF EARLY HEAD START FINANCIAL REPORT, JANUARY 2019: On a motion by Mr. Larry Horton, seconded by Mr. Steve Sallee, all members voting aye, the Board voted to approve the Early Head Start January 2019 Financial Report as presented on behalf of Head start Director Kathy Wilcox.

APPROVAL OF HEAD START FINANCIAL REPORT, JANUARY 2019: On a motion Ms. Linda Gillenwater, seconded by Mr. Steve Sallee, all members voting aye, the Board voted to approve the Head Start January 2019 Financial Report as presented on behalf of Head start Director Kathy Wilcox.

Superintendent Ferguson reviewed the February 2019 Head Start Director's Report as presented on behalf of Head start Director Kathy Wilcox.

Superintendent Ferguson reviewed with the Board the Maintenance updates on behalf of Mr. Robert Sallee, Maintenance Supervisor.

DIGITAL APPLICATIONS

Grades: 9

Prerequisite: NA High School Credit: 1

Digital Applications is designed for secondary school students to develop real-life, outcome-driven approach skills for digital citizenship, basic computer operations, keyboarding, and application software (word processing, spreadsheets, multimedia applications, databases), and career exploration. This course promotes skills that can be applied across the curriculum and offers preparation relevant to 21st century skills and postsecondary education.

EARTH SCIENCE II – Advanced Survey of Earth Science Topics

Grade: 11-12

Prerequisite: Earth Science I

High School Credit: 1

Students will continue their study of earth science in this upper level science course. Earth Science II will build on the concepts learned in Earth Science I. The Earth Science standards connect the study of Earth's composition, structure, processes, and history; its atmosphere, fresh water, and oceans; and its environment in space. The standards emphasize historical contributions in the development of scientific thought about Earth and space. The standards stress the interpretation of maps, charts, tables, and profiles; the use of technology to collect, analyze, and report data; and the utilization of science skills in systematic investigation. Problem solving and decision making are an integral part of the standards, especially as they relate to the costs and benefits of utilizing Earth's resources. Major topics of study include plate tectonics, the rock cycle, Earth history, the oceans, the atmosphere, weather and climate, and the solar system and universe. CALCULUS II Grade: 12

Prerequisite: Calculus 1 High School Credit: 1

Calculus II is designed for students pursuing an advanced high school diploma and is recommended for students interested in careers in mathematics, science, or engineering. Topics include (but are not limited to): antiderivatives, the Fundamental Theorem of Calculus, solids of revolution, integration, and basic power series representations.

CALCULUS II DUAL ENROLLMENT

Grade: 12

Prerequisite: Calculus I DE High School Credit: 1 College Credit: 4 hours

Calculus II DE is designed for students pursuing an advanced high school diploma and is recommended for students interested in careers in mathematics, science, or engineering. Topics include but are not limited to: antiderivatives, the Fundamental Theorem of Calculus, solids of revolution, integration, and basic power series representations.
